The Anglican Diocese of Toronto has established a Pre-Authorized Remittance Program (PAR) to assist you in your support of the work of your parish church and its ministries and programs.

## Who looks after the Program?

The United Church of Canada administers the PAG program for St. George's Memorial Church. The United Church has a large, efficient program and gives us excellent service and monthly reports. Your offerings are recorded by our Financial Officer and you will receive a tax receipt from St. George's Church after year end.

## How do I Enroll?

1. Decide the amount of your monthly offering.
2. Fill in the Authorization Form on the back page of this brochure and attach a sample cheque from your bank account marked "VOID."
3. Give both to the Financial Officer or place them on the offering plate in an envelope. Your submission will be treated with the utmost confidentiality.
4. Any future changes can be handled by phone, e-mail or in person.
